

AMENDING AND SUPPLEMENTING ORDINANCE 64-2020 TO AMEND RATES,
CHARGES, AND FEES FOR ALL RECREATIONAL FACILITIES AND PROVIDING FOR
IMMEDIATE ENACTMENT

WHEREAS, Council adopted Ordinance 64-2020 for rates, charges, and fees effective November 12, 2020; and

WHEREAS, it is necessary to periodically review, establish and amend all rates, charges, and fees for the recreational facilities of the City to be effective February 1, 2022; and

WHEREAS, the "Recreation Fees Grid", Exhibit A, requires a format update and streamlining; and

WHEREAS, a change is requested to adjust various admission rates and membership fees.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TALLMADGE, COUNTIES OF SUMMIT AND PORTAGE, STATE OF OHIO:

SECTION 1. That the rates, charges, and fees as reflected on the "Recreation Fees Grid", Exhibit A, attached hereto and incorporated herein, are hereby established effective February 1, 2022, unless otherwise noted.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after November 28, 1975 that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this ordinance is necessary to provide for and to accomplish the purposes herein set forth, which are conducive to the health, safety, and welfare of the citizens of Tallmadge. For that reason, provided this ordinance shall receive the affirmative vote of three-fourths of the members of Council and approval by the Mayor, it shall be enacted immediately and shall be of immediate effect.

City of Tallmadge Employee Discount	A 50% discount off the posted rates will be given to all City of Tallmadge employees and their dependents, retirees, current board/commission members, Auxiliary police officers (after probationary period) and former elected officials (who have completed at least 1 full term).
Tallmadge City Schools Employee Discount	A \$5/month discount will be offered on annual memberships to all employees of Tallmadge City Schools. The discount does not apply to the employee's dependents or to monthly memberships.

Special Rental Rates of Tallmadge Recreation Center Facilities

Teams registered and paid for Tallmadge Parks & Recreation Department sponsored leagues received 50% off court/field rental for team practices. This discount is in effect up to one month prior to the start of the league and ends when the season ends. All participants must be on the active roster. Reservations must be made by the team manager/coach. A detailed report of these discounts will be supplied to the Director of Public Service when requested.

Community based teams with a roster that consists of 60% or more of Tallmadge residents receive a 50% discount off court/field rental for practices, tryouts and games. This discount does not apply to court set up fees or field light usage.

Tallmadge Relay for Life permitted to use track, soccer field, basketball courts, multi-purpose room, south east parking lot and aerobics rooms once annually for the Tallmadge Relay for Life walk. Set up of areas may begin the day prior to the event. In exchange, Tallmadge Recreation Department is named a sponsor of the event.

Tallmadge Relay for Life permitted to use one basketball court for 2 hours once annually for Hoops for Hope fundraiser.

Tallmadge Chamber of Commerce permitted exclusive use of the track, soccer field, basketball courts, lobby, multi-purpose room and aerobics room once every other year for the Tallmadge Expo. Set up of these areas may begin the day prior to the event. This event is co-sponsored by the City of Tallmadge.

American Red Cross permitted to use the Tallmadge Recreation Center as a possible emergency shelter location free of charge when available/needed.

Organizations offering classes and trainings that benefit the Parks & Recreation Department, such as fitness instructor trainings, are permitted to use the facility at no cost in exchange for free enrollment for Recreation Center instructors, staff and/or members.

Per the use agreement with Tallmadge City Schools, School athletics are permitted use of up to three facility areas from 3 pm-6 pm, Monday through Friday free of charge. Schools will have exclusive use of these areas during these times.

Tallmadge Parks and Recreation Department Donation Requests

Donations may be made to "qualified groups" by written request to the Tallmadge Parks & Recreation Superintendent for approval. A "qualified group" is a nonprofit group based in Tallmadge and/or serving Tallmadge residents, a sporting or fraternal organization based in Tallmadge, or a group organizing a charitable event for the direct benefit of a Tallmadge resident(s). Donations will consist of one Blue Month Membership, a water bottle, a shirt or other miscellaneous items if in stock, and will be limited to a \$50 total monetary value. Donations will be limited to one package per organization per calendar year. Monthly reports will be provided to the Governing Board.

All other adult and youth programs, leagues, tournaments, camps, events and other programs (Program Grid)

Tallmadge City Council hereby authorizes the Director of Public Service, upon recommendation of the Manager of Parks and Recreation and within the limitations of the current year budget as authorized by Council, to approve the implementation of all Parks and Recreation Department adult and children's programs, leagues, tournaments, camps and special events and the associated user fees and charges subject to the approval of the Director of Finance, Director of Law and Governing Board. A current list of all such approved fees and charges shall be maintained in the Recreation Department, Finance

Tallmadge Parks and Recreation Department Refund Policies

If a program is canceled by the Tallmadge Parks and Recreation Department, all participants will receive a full refund.

The Tallmadge Parks and Recreation Department has a limited refund policy for all memberships, programs, leagues and facilities. All refund requests must be submitted in writing to the Parks and Recreation Superintendent and must include the reason for the request. All requests will be reviewed on a case-by-case basis and fees may be assessed per the guidelines below. Fees may be waived in the case of extenuating circumstances at the discretion of the Parks and Recreation Superintendent.

For all membership and program refund requests, fees will be waived if the request is made due to:

- *Medical reason with proper documentation from a physician
- *The individual has moved more than 30 minutes away with documentation of new address

TRC memberships: Requests for cancellations for reasons other than distance or medical will be granted on a case-by-case basis for annual memberships only. These requests will be assessed a fee equivalent to the price difference between an annual membership and a monthly membership for the months elapsed from the purchase date.

Annual EFT Memberships will automatically renew at the current annual rate. Members must request cancellation of their membership to stop billing. Requests to cancel received more than 30 days after the renewal date will be assessed cancellation fees as listed below. Cancellations requested more than 270 days after the renewal date will not be permitted.

Maca memberships: Requests for cancellations for reasons other than distance or medical will be granted on a case-by-case basis and will be assessed a fee equivalent to the daily admission rate for the days used or 10% of the membership cost, whichever is greater.

Activities and programs: Requests for cancellation received more than one (1) week in advance will not be assessed a fee. Requests received less than one week prior to the start of the program for reasons other than medical or distance, may be assessed a fee of \$5 or 10% of the program cost, whichever is greater.

Leagues: Requests for cancellation after the league schedule has been made will only be granted if another team is found to take the spot. All refund requests may be assessed a 10% cancellation fee.

Facility Rentals: Facility refund requests will be assessed cancellation fees per the terms of the rental agreement. For rentals without a signed rental agreement, cancellation requests will be granted on a case-by-case basis for any request made more than one (1) week in advance. Efforts will be made to reschedule the rental if possible. If the rental cannot be rescheduled, a cancellation fee of 10% may be assessed.
